## CLASS DESCRIPTIONS

**Creative Crafts - Grades 1-2 Wednesday afternoons with Mrs. Mora, Room 121 (class size limit 12):** This class is filled with innovative craft-making experiences that are sure to keep growing minds engaged and fulfilled! The course will allow students to use their own creative flair to produce one-of-a-kind, personalized works of art. **\$15 supplies fee.**

**Duets for Strings - Tuesday mornings with Mrs. Goldberg, room 131 (K-6 welcome, but the student must have at least one year experience playing violin, viola, cello or bass) (class size limit 12):** Join Mrs. Goldberg and learn some exciting string duets! There will be informal performance opportunities (of the music learned together) at Munsey Park.

**Gifts of the heART Crafting - Grades 3-5 Wednesday afternoons or Friday mornings with Mrs. Levine, Room 229 (class size limit 10):** Come to create, design and give gifts of the heART. Completed projects can be shared with loved ones for birthdays, holiday gifts or just to say I was thinking of you! Anticipated projects: a wood sign, winter craft, holiday ornament, memory box/bucket list box project and more! Each gift will be wrapped with love. **Materials fee \$15.**

**Kindness Club - Grades 4 - 6 Wednesday mornings with Mrs. Levine, Room 229 (class size limit 20):** Our club focus is to learn small ways to pay it forward. Projects

may include kindness rocks, collecting and wrapping hotel toiletries for families in need, collecting gently used books for Book Fairies, making cards for US veterans. We find ways to promote random acts of kindness. Together, we will make a difference in the lives of others. Please bring 8 quarters to our first meeting. We will be making random acts of kindness cards to be placed at a vending machine for a treat.

**Legos - Grades K-2 Thursday mornings with Mr. Putnam, Room 217 (class size limit 12):**

Students will build and create with Legos. Each week students will accomplish a specific task with their Legos based on various themes.

**Readers' Theatre Grades 2-3, Wednesday mornings with Mrs. Olwy, Library (class size limit 15)** Join Mrs. Olwy in the library as we combine children's literature with theater. We will use color coded, age-appropriate scripts created from well-loved children's stories. We will incorporate puppets and a small puppet theater into the children's performances. Children will practice reading with expression, fluency, and comprehension skills in a fun and stress-free setting

I acknowledge that the SCA and their directors, officers, volunteers, representatives and agents are not responsible for errors, omissions, acts or failures to act of any party or entity conducting a specific event or activity on behalf of the SCA. I agree that this obligation to indemnify and hold harmless the SCA shall survive after the end of the Activity.

**TO RELEASE AND DISCHARGE THE SCA AND ALL OF ITS AFFILIATES, MANAGERS, MEMBERS, AGENTS, ATTORNEYS, STAFF, VOLUNTEERS, HEIRS, REPRESENTATIVES, PREDECESSORS, SUCCESSORS AND ASSIGNS, FROM ANY AND ALL CLAIMS OR CAUSES OF ACTION AND I AGREE TO VOLUNTARILY GIVE UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING A LEGAL ACTION AGAINST THE SCA FOR PERSONAL INJURY OR PROPERTY DAMAGE.**

To the extent that statute or case law does not prohibit releases for negligence, this release is also for negligence on the part of the SCA, its agents, and employees.

In the event that I should require medical care or treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

**Allergies: The SCA is not responsible for any reactions, illness, injury, or other loss suffered or caused for known or unknown allergies. By signing below, you acknowledge that you have read and understand this statement and exclude the SCA from any liability.**

In the event that any damage to equipment or facilities occurs as a result of my or my family's willful actions, neglect or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any actions of neglect or recklessness.

This Agreement was entered into at arm's-length, without duress or coercion, and is to be interpreted as an agreement between two parties of equal bargaining strength. Both the Participant and the SCA agree that this Agreement is clear and unambiguous as to its terms, and that no other evidence will be used or admitted to alter or explain the terms of this Agreement, but that it will be interpreted based on the language in accordance with the purposes for which it is entered into.

In the event that any provision contained within this Waiver and Release of Liability shall be deemed to be severable or invalid, or if any term, condition, phrase or portion of this agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this agreement shall remain in full force and effect, so long as the clause severed does not affect the intent of the parties. If a court should find that any provision of this agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, construed and enforced as so limited.
